TEACHING

Free Expression, Mass Media, and the American Public (EMC/JOUR./RIM 3650, MTSU, Fall, 2009): An examination of ethics, history, law and social science pertaining to freedom of expression and censorship. Topics include public opinion on civil liberties, defamation, obscenity, incitement to violence, protests, freedom of the press, copyright, the Federal Communications Commission, and expression on the Internet.

Quantitative Research Methods (MC 6110, MTSU, Spring 2009): Overview of quantitative research methods for mass communication research. Topics in research design include sampling, surveys, content analysis, experiments, and research ethics. Statistical topics include use of SPSS, descriptive statistics, correlations, t-tests, chi-square tests, OLS regression, and ANOVA.

Persuasive Communication (COMM 367, OSU, Autumn 2007): Principles of persuasion as reasoned discourse. Topics include theories of persuasion, audience analysis, and public speaking.

Communication Research Methods (COMM 660, OSU, Summer 2007): Overview of quantitative research methods. Topics include measurement, sampling, research ethics, survey research, experimental research, content analysis, and data analysis using SPSS.

Advertising and Society (COMM 644, OSU, Summer 2006): Discussion of advertising's impact on culture, the economy, and society in general from scientific and critical perspectives. Topics include advertising directed at youth, depictions of cultural and ethnic minorities, sex and sexism, political advertising, advertising and health, social responsibility, and ethics.

Communication in Society (COMM 200, OSU, Summer 2005): Overview of the major theories, perspectives, and approaches that guide understanding of communication in various contexts. Topics include the distinctions between social scientific and critical cultural perspectives, and various theories dealing with aspects of interpersonal, organizational, and mass communication.
